RULES AND REGULATIONS GOVERNING THE PRESENCE OF DOGS IN THE CONSERVATION PARK

- 1. DOGS ARE <u>NOT</u> PERMITTED IN THE THORNBURG CONSERVATION PARK, ON-LEASH OR OFF-LEASH, ON THE FOLLOWING DAYS: <u>Wednesdays and Sundays</u>. On all other days, dogs are permitted in the park, on leash or off-leash, subject to the Rules and Regulations stated below.
- 2. Only dogs with valid and visible Borough permits are permitted in the Park.
- 3. There is no attendant present in the Park. All patrons of the Thornburg Conservation Park use the park at their own risk and the Borough shall not be liable for injuries to dogs or persons.
- 4. The Borough exercises no custody, care or control of dogs in the park and the dog owner or handler is 100% responsible and liable for any injuries inflicted by his or her dog.
- 5. All dogs must be on a leash and under the control of their owners or authorized handlers while within 50 feet of an entrance to the park.
- 6. No dog is permitted in the Park without its owner or authorized handler present at all times and within view and voice control of his or her dog.
- 7. A maximum of two (2) dogs is permitted per handler while in the Park.
- 8. All dogs must wear collars with the following tags visible at all times: Rabies, County license and the Borough permit tag. All tags must be current.
- 9. All handlers must have a leash for each dog in their possession at all times. Dogs must be leashed by their owners immediately at the first sign of aggression or unruliness and removed from the Park.
- 10. Dogs may not chase, hunt or harass people, wildlife or other dogs.
- 11. Dog owners/handlers must pick up and dispose of their dog's excrement.
- 12. Dog owners/handlers are solely responsible to repair any damage to the park caused by their dog.
- 13. If a dog owner/handler does not adhere to any of the above-mentioned Rules and Regulations, or any rules and regulations that may be promulgated in the future by the Borough Council, their permit or permits may revoked at any time without further notice.
